Republican Governors Endorsed the Balanced Budget Amendment campaign.

Republican governors sent a letter to Congress on January 11th offering to help Elon Musk and President Trump—in their cost-cutting efforts—reach the ultimate goal of a balanced federal budget.

The Republican Governors Association's (RGA) original plan was to send Congress a letter directly endorsing the state-led Balanced Budget Amendment campaign. That decision was approved by the RGA after a pitch by Gov. DeSantis, Gov. Sununu and Gov. Stitt on behalf of the non-profit *Balanced Budget Now*. Two months later, Elon Musk announced his desire to cut \$2 trillion from our yearly deficit to balance the federal budget. President Trump, intent on reducing the size of government, created DOGE to give Musk a vehicle to pursue these cuts.

This prompted the Republican Governors Association to alter its letter to Congress by applauding President Trump and Elon Musk for their cost-cutting efforts, and offering to <u>help</u> them reach the ultimate goal of a <u>balanced federal budget</u>. That was the RGA's indirect way of endorsing the Balanced Budget Amendment campaign because amending the U.S. Constitution to require a balanced federal budget is literally the only way that the states can <u>help</u> in this regard.
